ESAM - Environmental and Social Action Movement - Kevin Young

The group began in 2019 to create climate-related bargaining proposals plus supporting broader university response to climate change. In 2021 the group evolved and adopted the name Environmental and Social Action Movement (ESAM). It is a coalition among campus unions and student activists, and an extension of the earlier student-led fossil fuel divestment movement. A current focus is the "Stop the Money Pipeline" campaign and there is currently a petition being circulated demanding that the university transfer contracts and accounts away from financial institutions whose policies are inconsistent with limiting global heating to 1.5 degrees C over preindustrial levels. UMass continues to be connected to the fossil fuel industry through use of banks, insurers, asset managers in the finance industry. The group's goal is to pressure these financial institutions to stop funding fossil fuels and divert money and resources to renewables. If we can get UMass to divest from using these financial institutions it could have a huge impact locally and nationally. The group is asking MSP to sign and endorse the petition. Motion to endorse MSP signing the petition was offered by Kevin Young. Asha Nadkarni seconded. Adopted unanimously by voting members of the Board.
